Fee assessment policy

Fees are assessed from the first date of contact, including e-mail or phone communication. This date will be considered the "invoice date" that determines the appropriate fee amount.

Web Updates

Web listings are updated at least once a month, for complete applications only. Applications are considered complete when the payment and all other required documents have been received and are approved by CRRC staff.

Membership Dues

Membership dues are assessed according to the following monthly schedule, except for Class B dues, which are always \$55. Class B membership fees paid in December cover the current year plus all of the next year.

Product rating application fees are not prorated, since they are relatively small and fees cover CRRC processing costs only.

³ A Color Family Group is established upon receipt of a product rating application for a Color Family Representative Element along with payment of \$225 for the group and renews annually at \$130.

⁴ The Conversion of a Standard Roofing Product to a Color Family Product fee is a one-time fee, after which renewal fees will follow the Color Family Element Renewal fee structure.

⁵ Custom Color applications accepted only from companies already participating as Licensed Sellers.

IMPORTANT NOTE: There are additional fees associated with a product rating that are not listed in the above table. Fees will be incurred through initial/aged radiative properties testing performed by the Accredited Independent Testing Laboratory (AITL) of your choice. There is also a fee associated with sample weathering on the test farm. The CRRC does not regulate these costs; they are solely determined at the discretion of the AITL or Test Farm. Please contact your chosen AITL or Test Farm directly to discuss cost.

International Licensees

While Random Testing costs are built into the existing program fee structure, there may be higher costs associated with collecting products from international locations. The CRRC may invoice these companies for the marginal costs above typical costs for U.S. product collection. The invoice may be issued any time after the product has been received by the CRRC.

Laboratory and Test Farm Fees

These fees only apply to Accredited Laboratories/Test Farms and new Laboratory/Test Farm applicants. They do not apply to companies seeking a product rating.
