


Strategic Goal

India Engagement

India is a massive potential market for cool roofs and walls that is poised for growth, based on the pace of new building construction, the proliferation of cool roof requirements at the state level, and engagement from the national government.

National Disaster Management Authority



- Met with the Joint Secretary and the Head of NDMA (now the Assistant Sec Gen for UNDRR)
- Spoke at NDMA Heat Action Planning Conference
- Updating national heat emergency guidelines to include cool roofs and other longer term heat risk mitigation strategies
- 23 Indian state have adopted heat action plans of varying quality – the new NDMA guidance will drive new adoptions and revisions

State of Play for Cool Roofs

- 500+ manufacturers/sellers
 - Mainly small companies
- Emergence of state-level policies
 - Green codes
 - 1–2% of market satisfy those requirements
- 90% testing primarily by one lab
 - ASTM standards

Opportunities and Challenges in India

Growing demand to:

- develop Indian teststandards
- build test lab capacity
- adopt accelerated aging

Key barriers are:

- low awareness
- lack of product
 performance/quality
 mechanisms
- untrained labor
- technical challenges (e.g., outdoor weathering)



India Outreach - Phase 2

- Continue advancing stakeholder relationships to integrate CRRC into local initiatives
- Identify and secure funding to provide advice and technical support to stakeholders
- Engage with local stakeholders to support their goals to translate American standard(s) for Indian adaptation

India Outreach – Phase 2 (continued)

- Support/advise CRRC staff to optimize engagement of planned on-site lab training trips around India
- Work with CRRC staff and CRRC International Committee to:

 - Develop and pursue a revenue strategy to self-sustain international engagement (e.g., fee schedules, funding opportunities)
