All fees and dues are on a January to December billing cycle.

Overview

This document describes the fees and dues structure for CRRC Licensees, CRRC Rated Products, CRRC-approved test labs and test farms, and CRRC Members. CRRC Wall Rating Program fees are separate and are described in the CRRC Wall Rating Program Fee Structure found here: https://coolroofs.org/programs/wall-rating-program/all-forms-2.

The CRRC charges an initial fee or due for first-time Licensees, Members, rated products, and test labs and test farms, and a renewal fee or due each subsequent year.

Payment of fees and/or dues must be made before Licensee, product rating, and/or test lab/test farm applications are approved by the CRRC. All other required information and documentation must also be submitted to and processed by the CRRC in addition to the payment of fees and/or dues. Members pay the initial dues after the application has been approved by the CRRC Board of Directors.

Payment of Licensee fees, product rating fees, test lab/test farm participant fees, and Membership dues for existing Licensees are handled through the CRRC Online Rating Portal.

Product Rating Fees and Dues

Product rating application fees are not prorated. The fees cover CRRC processing costs only.

A Color Family Group is established upon receipt of a product rating application for a Color Family Representative Element along with payment of \$260 for the group. The product fee for annual renewal is \$155.

IMPORTANT NOTE: There are additional fees associated with a product rating that are not listed in the above table. Fees will be incurred through initial/aged radiative property testing performed by an Accredited Independent Testing Laboratory (AITL) of your choice (see list of AITLs here). There is also a fee associated with three-year weathering at an approved CRRC test farm (see list of test farms here). The CRRC does not regulate the costs charged by an AITL or test farm. Please contact an AITL or test farm to find out what they charge for testing and weathering, respectively.

Licensee Fees

Annual roofing product sales is the total global sales of roofing products for your company and is not limited to sales of CRRC-rated products or regional (e.g., US) sales. Roofing products are only limited to the types of products that are rated by the CRRC (e.g., shingles, capsheets, coatings, tile) and do not include underlayments, fasteners, insulation, and other parts of a roofing assembly. Fees are based on the first date of contact with the CRRC. That date will be considered the "invoice date" that determines the appropriate fee amount.
