#### Effective January 1, 2022

All fees and dues are on a January to December billing cycle.

### Overview

This document describes the fee structure for participation in the CRRC Wall Rating Program (WRP), and covers WRP Licensees, WRP Accredited Manufacturer Test Laboratories (WRP AMTLs), and Product Rating Fees. CRRC Membership and fees for CRRC Independent Test Labs and Test Farms are separate, and are described in the CRRC Fees and Dues Structure found here: <u>https://coolroofs.org/programs/roof-rating-program/all-forms</u>.

The CRRC charges an initial fee for first-time Licensees, rated products, and a renewal fee each subsequent year.

Payment of fees must be made before Licensee or product rating applications are approved by the CRRC. All other required information and documentation must also be submitted to and processed by the CRRC in addition to the payment of fees.

Invoices for Wall Rating Program fees are handled through QuickBooks Online.

**IMPORTANT NOTE:** There are additional costs associated with obtaining a product rating that are not listed in the above table. CRRC Accredited Independent Test Laboratories (AITLs) charge for testing services for initial and aged radiative properties. CRRC weathering farms also charge fees for product exposure. The CRRC does not dictate what AITLs and weathering farms can charge for testing and weathering, respectively.

## Licensee Fees

Licensee fees are paid annually, and are prorated for the first year when the Licensee first joins the Wall Rating Program. Licensee fees are determined by the annual sales of exterior wall products. Annual exterior wall product sales are the total global sales of exterior wall products for the company and is not limited to sales of CRRC-rated products or regional (e.g., US) sales. Exterior wall products are only limited to the types of products that are rated by the CRRC (e.g., paint/architectural coatings, metal cladding, stucco, vinyl siding, etc.) and do <u>not</u> include underlayments, fasteners, insulation, and other parts of a wall assembly. Fees are based on the date the Licensee application is received by the CRRC.

A Licensee can optionally join the Wall Rating Program as an Accredited Manufacturer Test Lab. AMTLs can submit product rating data for Color Family Additional Elements, and are subject to additional program requirements. For more information about AMTLs see <u>coolroofs.org/</u>.
